**NOTICE INVITING TENDERS**

Bidding is open to all interested bidders.

2. Procuring agency invites sealed bids from interested firms or persons registered with relevant tax authorities.

Bids will be opened at 02:00 P.M on the same day, in the presence of bidder's / bidder's representatives who choose to attend at the same address.

  - f) Registration with Federal Board of Revenue (FBR), for Income Tax, Sales Tax, Registration with the Sindh Revenue Board and registration with Pakistan Engineering Council C6 and above.
