No.2/4-SO(R&S)/2024-25: In exercise of the power conferred by section 44 of the Sindh Irrigation Act 1879, read with Section 70, thereof, and with the approval of Provincial Caretaker Cabinet Sindh in its meeting held on 20th February 2024 under the Chairmanship of Caretaker Chief Minister Sindh, the Government of Sindh are pleased to direct that the Abiana (water rate) prescribed by Irrigation Department vide Notification NO.2/4-SO(R&S)/99/P-V dated the 27th January, 1999 shall stand increased by 100% (hundred percent) for irrigation purposes with effect from Rabi 2023-2024.
