

Report on the Inaugural Ceremony of Canal Modernization

1- Introduction:

The overarching theme of SWAT project is the *water* and agricultural nexus. The project will help boost Sindh's rural economy and address water-related environmental degradation. Hence, Sindh can get much more value from its agricultural sector while using less water. The SWAT project is designed to start the transformation process that, including: (i) creating an institutional framework for IWRM; (ii) modifying a century-old system of rigid irrigation practices through a modernization process centered on flexibly meeting the water needs of farmers; (iii) moving away from a



and (v) synchronizing agricultural and irrigation investments through a community driven development process at the FO level that will help ensure on-the-ground results that directly benefit farmers.

2- Canal Modernization Component

The overall objective of this component to improve the delivery of canal water services to enhance agricultural water productivity and to improve overall water resources management. In this component it was proposed that selected channels will be taken up for modernization. Initial 3 channels one from each AWB is selected.

3- Proceedings:

The inaugural ceremony for series of trainings on Canal Modernization under SWAT was held on 26/09/2023 at SIDA Secretariat & H&R Lab Hyderabad. The ceremony was chaired by Managing Director (SIDA). The participants from FAO (UN) Delegation, SIDA Officials, including PD (SWAT), Civil Society, NGOs and Area Water Boards representatives. List of participants given in the end. The primary focus of the meeting was to introduce the canal modernization



project and gather insights and guidance/views from the participants.

4- Key Points Discussed:

a- Managing Director's Opening Remarks:

- The Managing Director began by discussing the SWAT project, emphasizing the importance of watercourses, water distribution, and the need for measuring water channels.
- Mentioned a sample model developed in the hydrology lab, the collaborative effort of Mr. Habib Ursani, Mr Sajjad Soomro, and others.
- Emphasized the importance of the meeting to seek input and guidance from the participants regarding the project's changes and its potential benefits.



- Dr. Ansari introduced the concept, highlighting that this process was being introduced for the first time in Pakistan.
- Stressed the potential benefits and provided insights into how the process has worked in California.
- Mentioned the need for proper training in Pakistan and improving the understanding of modern techniques.
- He was concerned as this was happening for the first time in Pakistan.





- Participants raised concerns about the disparity between Pakistan and California, specifically in terms of water costs and the
 - need for revised water rates.
- The importance of technical terms' adaptation in the local context was discussed.







 Mentioned the need for improving rules, regulations, and laws related to water distribution.

d- Sajjad's Experience:

- Sajjad shared insights from his experience, highlighting factors such as water cost, equilibrium, and revised water rates.
- Managing Director redirected the discussion towards policy and the necessary changes.

e- FAO's Involvement:

• FAO expressed their commitment to working with SIDA, emphasizing the necessity of water for every country.

• Mentioned concerns related to climate change and the social aspects of water

management.

f- Chairman's Closing Remarks:

- The Chairman thanked all the participants and discussed the challenges faced in the project.
- Mentioned the increased water supply to farmers in Kotri barrage and income improvement.
- Highlighted issues in the drainage system in
 District Badin and the need for training farmers to increase production.
- Emphasized the importance of utilizing water properly.
- Discussed the increase in rice production and better rice rates.
- Mentioned upcoming projects, such as the Nara canal, and the support of the World Bank.

5- Second Session:

 Engineers discussed the difficulties they were facing, including LBD issues, water scarcity due to early and late khareef, and the need for improved water distribution.







- Administrative weaknesses and issues with the Crop pattern were raised.
- The lack of timely warnings before rain or floods was a concern.
- The importance of administrative reform was discussed.

6- Sajjad Soomro's Presentation:

- Questions were raised about the water distribution process, and the comparison with California was made.
- Control in upstream and downstream was discussed, and challenges related to cross regulators were highlighted.



7- MD's Closing Remarks:

- The Managing Director discussed the increase in water productivity after the project.
- Emphasized the need for proper water utilization and the importance of farmers' understanding.
- Mentioned the distribution of water according to flow and calculated and measured water supply.



8- Conclusion:

The Inaugural Ceremony of Canal Modernization provided an opportunity for participants to discuss the challenges and opportunities in modernizing canal systems in Pakistan. The importance of proper training, social mobilization, and effective management was highlighted throughout the meeting. The event concluded with optimism about the potential benefits and positive changes the project can bring to the region.
