Activity Report for the Month of November 2013

A- Institutional Development of Farmers Organization

1. FO FORMATION:

NCAWB:

The Social Team of NCAWB has taken the initiatives for FO Formation. In this regard team conducted the meeting with the farmers of Girhore Distry at GPS Samaro Mori with the support of AWB staff. The meeting started with the name of Almighty Allah and then field team briefed about the participatory irrigation system and its benefit. In this meeting the some farmers were already aware and shown keen interest in formation but they showed their great apprehension regarding traditional irrigations staff behavior with the farmers organization. Moreover, Field Team Umerkot taken initiative for mobilization meeting with the farmers of Noor Wah at otaq of Noor Ali Shah sahab. Mr. Noor Ali shah a progressive farmer showed some reservation at the formation on FO. Finally it was decided that in next meeting some higher authorities of AWB will be invited in the meeting for the process of FO formation. The efforts for formation of FOs in NCAWB are underway.

GFCAWB:

GFCAWB has already completed three FOs out of 5 minors, the work on two minors are underway:

1. FO formation is in under process on **Imam Wah**, 50 water course associations formed out of 100 water courses.
2. FO formation process on **Desert Minor**, is completed, 13 water course associations formed and Election will be held in the month of December 2013.

Work is underway and it is expected that during January 2014 both FOs will be formed.

LBCAWB:

During the month of Novemebr-2013, Social team of LBCAWB focused on formation of four FOs. After working of the minor , it was known that the formation on two minors is not possible. Details are as under:

1. **Adu Wah:** Mobilization meetings were held with different groups of farmers from head to tail, and a base line survey has also been completed. The team hoped that this formation will be completed during January-2014.

2. **Chaneri Distry:** Mobilization meetings were held with farmers and Baseline survey is completed, so it is expected that FO formation will be completed in the end of January-2014.
3. **Jamari Link Minor:** After detailed survey along with Gaja Sub Division irrigation staff, it was revealed that this minor is in the command of Pinyari circle and not in LBCAWB control so FO cannot be formed on this Minor.
4. **Pandhi Link Minor:** After visiting the minor it was revealed that Pandhi Wah and Pandhi Link Minor was single minor some years ago, but then they were divided into two minors. Since years Pandhi Link Minor is used as a drain, the water courses are shifted from it and it is non-functional now. The same has also been reported by Assistant Executive Engineer Jalalani Sub Division. So it is not possible to form FO on this Minor as it is used as drain and no any cultivation on it.

2. RE-ELECTION OF FARMERS ORGANIZATIONS:

During the month of November 2013 overall three re-elections of FOs have been done in AWBs, two in NCAWB and one in GFCAWB. No any re-election done in LBCAWB. The work is underway on 21 FOs in AWB and Social Mobilization Staff is striving hard to assist FO for re-election process.

NCAWB:

The Social staff of NCAWB has been taken strong initiatives to assist FO Re-Elections and clear the backlog. In this regard during the month two re-elections of Doso Minor and Rawtiani Minor was successfully held on 18th & 29th Nov 2013. There was acute conflict on Doso Distry & after verdict from Honourable Court the team taken efforts to hold re-election and was successfully achieved. Both re-elections were keenly monitored by SIDA, AWB and M&E Consultants.

4. CONFLICT RESOLUTION:

NCAWB:

During the month, the Field Teams resolved 03 FO internal conflicts, all of these conflicts were regarding the FO/WCA re-elections. Field Team Mirpurkhas resolved the conflict of FO Dosso Distry and successfully conduct the re-election process at the Distry by the election committee. The Field Team Sanghar resolved the conflicts of FO Rawtainai Minor; the conflict among the farmers was on the issue of representation of tail end farmers. The staff held meetings with both the groups and through the social mobilization resolved the conflict and at the end FO re-election held successfully. The Field Team KGM resolved the conflict between the FO Puran feeder and Assistant Executive Engineer on the issue of proper gauge of water at the head regulator. The KGM field staff of social Mobilization assisted to both parties and successfully resolved the issue of proper gauge.

Apart of this field team Mirpurkhas assisted in conflict resolution at Khori Distry for constitution of election committee at the Distry to initiate the re-election process, matter was discussed in detail between the parties. After detail meetings at the end names were announced by all stake holders/farmers of Khori Distry.

GFCAWB:

During the month of November no any conflict reported in GFCAWB.

LBCAWB:

During the month of November 2013, the conflict of Ahmed Rajo & Gurho Minor successfully resolved. Moreover, the AWB Social Staff also successfully resolved four conflicts of FO Macheri Minor, FO Ali Wah Large Minor, FO Saeeda Minor and FO Sorhadi Minor.

The conflicts were mainly on water issues and Rehabilitation works issue

Court Matters:

During the month of November-2013 (03) court cases were attended by social mobilization staff

1. **FO Ali Wah Large:** Disposed off in November-2013
2. **FO Macheri Minor:** Still in progress(water issue with irrigation staff of Matli sub division)

5-HANDS ON SUPPORT

A- Assist in Abiana Assessment & Collection

NCAWB:

In the current month of reporting, the Field Teams of SM mobilized FOs for depositing of Abiana (water charges) to AWB. The Field Teams held 5 special meetings with the FOs for collection of Abiana from the members and deposit in the account of AWB as 60% share. In the result of these meetings, FO Jageer Minor paid 100% along with Theba minor Khori and Rohro Minor is also deposited amount in the account of AWB. The remaining FOs is in the process of collection of Abiana from the farmer members and deposit to AWB.

Field office Umerkot participated in the coordination meetings with FOs and revenue staff at Umerkot and Kunri subdivisions to discuss the collections of abiana and other matters of FOs and subdivisions, the aim of the meetings to insure the maximum utilization of the supportive for the both parties (FOs and Irrigation AWB staff).

Field office sanghar participated in the coordination meetings with FOs and revenue staff at jhol and khadro subdivisions to discuss the collections of abiana and other matters of FOs and subdivisions, the aim of the meetings to insure the maximum utilization of the supportive for the both parties (FOs and Irrigation AWB staff).

During current month FO Sorah and RD-203 L/S has started Abiana for Kharif 2013. Similarly FO RD-203 L/S collected One lac eighty thousand rupees from their khatedars and waiting for reconciliation with AWB. The FO Chairman RD-203 has written a letter to SDO Nara Lift Subdivision Sukkur for reconciliation and Copy to Director Nara canal Area water board, Executive Engineer Thar Division, Social Development Specialist and General Manger Transition SIDA Hyderabad.

During current month, Field Team SIDA Choondko assisted FO Sorah minor, Saido minor , Simni and RD-203 minor in writing letters to Sub divisional officer (SDO) Nara Lift subdivision Sukkur for reconciliation of crop assessment figures and technical record..

Field team SIDA Umerkot assisted the FO Hingorno minor, FO Khahi Distry, FO Bhan Minor, FO Juma Distry, FO Kandiaro Minor & FO Doso Distry regarding the Abiana Collection. It was decided that FOs will collect the Abiana and deposited 60% in AWB Account. Due to cotton and rice crop FOs has good opportunity to collect the abiana from farmers.

Field team SIDA Sanghar assisted FO Sinjhor, Duthro-11, Khori and Rind minors in functioning of FO offices and record keeping

LBCAWB:

Abiana target for Kharif-2014 along with Abiana defaulter's lists was submitted by many sub divisions of LBC-AWB and recovery is also started in many sub divisions. Abiana meetings were also held on (02) FOs during reporting month;

1. **FO Manik Wah:** Meeting of FO BoM and recovery staff of Jalalani sub division was held in the office of AXEN Jalalani sub division. Rs. 26000/= were recovered from Abdar, the said abiana amount was recovered by abdar but not deposited in the bank.
2. **FO Kario Wah:** Meeting of FO BoM and recovery staff of Jalalani sub division was held in Kario Ghanwar, the abiana amount was recovered by abdar but not deposited in bank.

GFCAWB:

Social team of SIDA/AWB is continuously taking efforts for the assistance, guidance and coordination with FOs within its jurisdiction regarding abiana.

2- Water Shortage Issues:

As per Honourable Supreme Court orders in a decision that the all tempered outlets of canals as well as channels should be made as per design, control water theft and ensure availability of water at tail reaches of the channels of Sindh. In this regard, under the supervision of General Manager Transition formed a Task Team, whose core task to mobilize FOs to control tempering of outlets. The Task Team consisted Mr. Fahad Bhurgari, Assistant Manager HRD, Mr. Parwez Ahmed Bambhan, Assistant Manager Transition, Mr. Muhammed Ghous Laghari and Mr. Mohsin Ali, Mr. Muhammed Arif Laghari, Institutional Specialist and Mr. Ali Akber Bugti Assistant Engineer SIDA. The team visited various FOs of LBCAWB and NCAWB and mobilize FOs as per their task.

NCAWB

The General Manager Transition called an emergency meeting with field staff on 29th November 2013 at SDA Secretariat Hyderabad in the compliance of Supreme Court orders. It was decided in the meeting that the all modules should be properly made as per design, water theft should be controlled and availability of water should be ensured at the tail reaches of the minors / distributaries. In this regard the General Manager Transition issued a letter to the all representatives of FOs. The field teams were directed to conduct emergency visits and meetings with representatives of FOs in this regard and handover the letter of General Manager Transition to the representatives of FOs.

Field team SIDA Sanghar, Choondko and Umerkot visited channels on 30th November 2013 on Saturday, and 1st December 2013 Sunday on emergency basis. The staff members visited the channels, and conducted meetings with the representatives of FOs and handed over the letter of GM Transition SIDA. The team mobilized the representatives of FO that the modules of channels should be made as per design, and availability of water should be ensured at tail reaches of the channels. The social staff of NCAWB also participated in these visits and meetings with FOs.

LBCAWB

Meeting was held on 29-11-2013 for compliance of Honourable Supreme Court of Pakistan directions in the Constitutional petition 59/2013 for rectification of illegal, unauthorized water courses in all Sindh Province and ordered Secretary Irrigation, Government of Sindh.

Social mobilization team and sub division AWB staff visited FOs and rectifies illegal, unauthorized water courses.

6-OTHER ACTIVITIES

6.1- 18th Monthly Staff Meeting SDC-Transition under WSIP-1:

18th Monthly progress review Meeting of SDC-Transition was held on 18th of November 2013 at SIDA Secretariat Hyderabad. Meeting was chaired by GMT-SIDA. In this meeting SDS-SIDA also participated. First of all the GMT-SIDA discussed about proper utilization of FO Offices. He said that field staff should ensure the proper utilization of FO Offices and the GBs and BOM Meetings should be held at FO Offices. The availability of the FO Office record at their offices will make them easy to maintain the record properly. It was also discussed that the Sign Boards should be installed at FO Offices for its proper identification.

It was discussed that FO Re-elections are essential for FOs legal Status. These elections may be conducted with the coordination of AWB Staff. The proper process and formalities should be followed and the date of re-election of BOM of FO must be informed to RA at least three working days in advance.

Operation & Maintenance Plan was discussed and this plan was prepared by field staff in the presence of SDS-SIDA. It was also discussed that now the rehabilitation works of channels have been completed so some case studies should be prepared and impact of rehabilitation works should be mentioned in the case studies like as crop yield is increased, water availability in the tail is increased, conflicts were resolved and any migrant returned back at the minor etc should be included in it. In the end the manager SM&G said that PCMU has appreciated the SDC-Activity Report of SIDA which shows our good effort.

6.2- Meeting of PCMU to review NC-01 & NC-02 and B2 components at NCAWB Mirpurkhas:

The meeting of PCMU was held at the Committee room of NCAWB on 21 November 2013. Representatives from PCMU/PCMA, SIDA, M&E, PIC, Contractors & FOs participated in the meeting. Also Social field team SIDA & NCAWB also participated. In this meeting Mr. Yellie, Mr.Fateh Mari, Mr.G.Hyder Qureshi, Mr. Nisar Memon, Mr. Nazir Essani, Mr.G.Mustafa Ujjan, Mr.Jay Ram, Mr. Jamal Manghan, Ex.Engrs etc participated. The qualities of works were discussed. As per the findings of the M&E the officials showed displeasure regarding the quality of works in B2 which were done at NCAWB FOs. It was suggested that PIC should ensure the good quality of work at FOs where it is possible. Also PIC should ensure to re-mobilize the contractor regarding Defect Liability period to complete the works. In the end social meeting was held, in which Formation of remaining FOs, IDMT, FO Conventions and Abiana Collection were discussed. It was discussed that FO Formation work is slow due to highly Political Interference and at most of the FOs this work may not be possible. It was suggested that we should try for this again and at least 50% target should be achieved. For IDMT of FO Toori and Sanghar minor efforts should be taken. Further it was also discussed that FO Conventions should be held at each district. For abiana collection it was discussed in length and Mr. Fateh Mari Project Coordinator said that try to improve the recoveries of abiana collection with the coordination of Executive Engineers along with FO representatives. Through this process good results will come out and the doubts of conflict will be reduced.

6.3- Participation of SIDA staff in Training at M.U.E.T Jamshoro:

A two days training was arranged by Mehran University of Engineering and Technology Jamshoro from 27 to 28 November 2013. The topic of the training was Watershed Rehabilitation and Irrigation Improvement in Rainfed Areas. Dr. Bakhshal Khan Lashari, Dr. M. Munir Babar & Prof.Dr.A.Latif Qureshi were the resource persons of the training. Some Engineers were nominated by SIDA to attend this training. Mr. Ali Akbar Bugti from field team Umerkot also participated in the training. Mr. Kela Ram a SDO of NCAWB also participated the training. The training was consisting on the topics of Sprinkle Irrigation System and Drip Irrigation System. Over all the training was fruitful and in this training Water Saving Methods and Schemes were discussed in the detail.

Moreover, the representatives of 22 FOs also participated in the workshop. MUET requested to send representatives of Farmers Organization. In this regard under the supervision of Mr. Masroor Ahmed Shahwani, Training Coordinator SIDA, 22 representatives were sent to MUET. The farmers were sent under the supervision of Mr. Ayaz Ali Khawaja, Assistant Manager SM LBCAWB and Mr. Muhammed Ghous Laghari, Institutional Specialist SIDA.

6.4- Five Days Training on Organization Performance Management- Tools for Improving Performance Indicators, Nov 25-29, 2013 PIM Karachi

During the Month, HRD Section SIDA under Component A of WSIP, sent its two officials Mr. Masroor Ahmed Shahwani, Act. Manager SM&G and Mr. Abdul Haq Lakho, to attend 5 days training course on **Organization Performance Management- Tools for Improving Performance Indicators** at Pakistan Institute of Management Karachi from 25th to 29th November 2013. Both officials successfully attended the course.

6.5- Refresher Training

During the month of November one refresher training held on FO Sorah minor on 28th November 2013. The training was conducted at FO office. The topic of the training was Sindh Water Management Ordinance 2002 (SWMO-2002). General Body members and active khatidars of Sorah minor participated in the training. Mr. Waqar Hussain I.S SIDA and Mr. Kausar Mangi AEN for FO delivered the sessions of training.

C- PROJECT IMPACT

1. Water Distribution

Water distribution in the channels under rehabilitation works WSIP has been improved. The cry from tail reach farmers has remarkably decreased.

2. Cropping Intensity

Since water reach has improved, therefore it definitely has positive impact on production, but this subject need thorough and comprehensive research survey to find out the actual figures of cropping intensity.

D- ISSUES

1- Field Issues:

The vehicles and bikes available in field were procured under SOFWM Project during 2005 and the condition is so worst. New vehicles should be provided in field.

2- Office Issues:

No any Office Boy and Office Assistant available in field offices. There are also old computers and printers and no internet facility. Rent agreements of Field Office SIDA Choondko, Ghotki and Badin are about to be expired on Dec 31st,2013. The rent agreements should be revised.

E- CONCLUSION

During the month of November 2013 Social field teams of SIDA and AWBs were fully mobilized to gear up an extensive program. After all it's all about the change and no one can impose the change at the level of any society/community. If the change becomes challenge for the system/community so it will require serious response. The field teams are striving hard to achieve their project targets under the supervision of SIDA/AWBs.
