The bid comprising of "Technical Proposal" and "Financial Proposal", the proposals must be submitted in separate sealed envelopes with clear marking of **"TECHNICAL PROPOSAL" & "FINANCIAL PROPOSAL"**, to the undersigned on **31.5.2022 @ fix 12.00 PM**. Initially only the envelop marked as Technical Proposal will be opened on same day @ fix **01:00 PM** by the procurement committee in the presence of the participants contractors / firms or their representatives who have power of attorney on stamp paper with original CNIC. The Technical Proposal shall be evaluated for technical qualification.
4. Bids / Tenders should be carefully and neatly filled and signed by the bidders. All bids must be accompanied by a bid security at rate of 5% of Bid Amount in the form of Bank Guarantee / Call Deposit / pay order that must be generated from the personal Bank Account of contractor / company / Firm in favour of Executive Engineer Jamrao Division Mirpurkhas from any National / Commercial Banks (un-named call deposit or pay order if any found not allowed as earnest money). The rationalized rates must be quoted by contractors in words / figures. Incomplete tenders, overwriting or conditional tenders shall not be entertained.
5. The Financial Proposals / bids of the technically qualified firms / contractors shall be opened and publicity announced on the date and time that will be communicated in writing to all qualified contractors / firms in advance. The envelope of Financial Proposals of technically unqualified contractors / firms shall be returned to them UN-OPENED.
6. All the Government Taxes including SST at the prevalent rates will be deducted from the bills.
7. In case of the undersigned or any member of procurement committee is out of head quarter or in case of public holiday, the bids shall be opened on next working day at same time and venue.
8. The bid validity period is 90 days.

Lining Job with documentary evidence along with satisfactory completion certificate of last 03 years from employer and details of on-going works with copies of letter of award of works with the value of equivalent to above mentioned amount in PKR and performance certificate.
 - The Contractors /Firms must have experience to carry out works of same nature in same geographical conditions of the scheme.
 - Contractors /Firms must have experience in Construction of C.C. Lining of Distributaries/Minors (Mandatory)
 - Detail of machinery equipment be reported with documentary evidence where ever applicable.
 - Technical and administrative staff be supported with evidence.
 - An average annual turnover during last three years should be minimum equal to project cost
 - Bank statement of last 03 years showing worth 50% balance in the bank statement of the bid cost on tendering time.
 - Income Tax Returns for the last 03 years & Sales Tax with SRB for last 03 years, specifically last year income tax clearance certificate / receipts.
 - Financial audit report from the authorized auditor of the Registered Chartered Accountant for the financial year 2018-19, 2019-20, 2020-21.
 - Valid Pakistan Engineering Council Certificate.
 - The instruction to bidders. Bidding Data, Conditions of contract mentioned in Standard Bidding Document (SBD) are applicable.
 - The Technical Proposal is submitted one in Original & Two Photocopies with the original Affidavit regarding not indulged litigation / firm is not black listed by any procurement agency / information documents also is absolutely true and correct.
 - Earnest money 5% of bid amount in shape of Bank Guarantee / Call Deposit / Pay Order must be attached with Technical Proposal.
