The project development objective of SWAT is to increase agricultural water productivity and improve water resources management. The project is being implemented by the GoS, mainly, through the Irrigation Department and its subsidiary organization the Sindh Irrigation and Drainage Authority (SIDA), and the Agriculture Department.

The primary objective of this Consultant assignment is to prepare an investment program on the RBCs for a follow-on World Bank financed project. A detailed description of the RBCS and a map of the RBCS are provided in the TORs. The RBCS is defined as all irrigation water supply canals that off-take from Sukkur Barrage, and associated drainage canals.

SIDA now invites eligible consultancy firms/joint venture(s) with specific and proven competence and experience to indicate their interest in providing the services. Eligible firm(s) should submit Expression of Interest (EOI) in the English language along with relevant complete details of the qualifications and experience.

Interested consultancy firms will be expected to demonstrate or provide explicit information/ evidence of their qualification to perform this assignment, in their profiles, in the areas covered by the project as indicated in the TOR. Firms should have specific and proven competence and experience in the planning and design of large irrigation and drainage systems, including associated environmental and social assessments that meet the requirements of multilateral development banks (MDB) such as the World Bank, Asian Development Bank, African Development Bank, etc. Interested consulting firms and consortia must provide information indicating that they are qualified to perform above services (e.g. brochures, description of similar assignments, value of similar assignments; etc); experience under similar conditions, availability of appropriate skill among staff; management of environmental and social safeguards; quality insurance and so on. For all assignment references, the firm should provide information on the contract period, the overall contract value, the contract value for the firm, and the role of the firm—such as lead firm, JV member, sub-consultant, etc.

Consultants are encouraged to provide only materials/information that would be specific to the proposed services, and to avoid submitting generic promotional material. The shortlisting considerations are as under.
